5. SCHOLARSHIP POLICY



5.1 OBJECTIVE

5.2 EFFECTIVE DATE & VALIDITY

The policy shall come into force with effect from 1 May 2021 with respect to and shall remain valid for 1 year i.e. academic session 2021-22 only. This will supersede all previous communication, rules, and regulation in this regard prospectively.

5.4 CATEGORIES

- (i) **BPL:** Any person having the residence proof of Rajasthan and latest & updated BPL-Card (Issued by Govt. or Raj.) are eligible for applying in this category.
- (ii) **SNS:** A student whose parent income is Low income (up to 2.5 lakh & as per latest RTE govt. income slab)
- (iii) **Scholar Student:** A student who is achieving scholarship on the basis of Class Percentile.
- (iv) **Judiciary services -**
- (v) **Political Services:** A person who is serving for people welfare works with a political party.
- (vi) **Bureaucrats' services -**
- (vii) **Defence Personnel services -**The term Defence Personnel would mean only those serving / retired Defence personnel from Army, Navy, Air Force. ... It includes children of Defence personnel who died while in service or after retirement.
- (viii) **Media services -** "Media" refers to various means of communication. For example, television, radio, and the newspaper are different types of **media**. The term can also be used as a collective noun for the press or news reporting agencies.
- (ix) **Police services -** The civil force of a state, responsible for the prevention and detection of crime and the maintenance of public order.
- (x) **Advocate /Lawyer - Advocate, in law,** a person who is professionally qualified to plead the cause of another in a court of law.
- (xi) **Medical Services -** Medical and health care services provided to a Person, including, but not limited to.
- (xii) **Staff Child:** Any child of staff (Teaching/Admin/Support Staff) active as on 30th April 2020 of Creative Public School and Creative Girls College only with blood relation as per objective of **H. W. & D. S. Constitution Point No. 1, 10, 13,14.**
- (xiii) **Gazetted Officer:** Person who is executive/managerial level ranked public servants in India. i.e. IAS, IES, IFS, Government Doctors, Government school Principals, Nationalize bank manager etc.
- (xiv) **Student:** A child who is studying in CPS with Unique Scholar number after completing all admission formalities
- (xv) **Parent:** Father – Mother of student who is studying in CPS school.
- (xvi) **School Advisory Board:** An advisory board is a body that provides non-binding strategic advice to the management of a corporation, organization, or foundation
- (xvii) **Director:** A person who is working as an Admin Head of organization & coordinator of scholarship committee for class XI & XII
- (xviii) **Vice Principal (Sec. Div.):** A person who is also admin head of organization & working as a single point of coordination of scholarship committee for class Pre Nur to X
- (xix) **Vice Principal (Sr. Sec. Div.):** A person who is also admin head of organization & working as a single point of coordination of scholarship committee for class XI & XII
